

Proceedings of the 61st Regular Convention of the Atlantic District of the Lutheran Church – Missouri Synod

I. OPENING OF CONVENTION

The 61st Regular Convention of the Atlantic District of The Lutheran Church—Missouri Synod was begun with God's blessing in Divine Worship at 12:30 PM and officially called to order at 2 PM by Bishop Lecakes.

+CONVENTION SESSION #1: FRIDAY, July 22, 2022 at 2 PM+

II. CALL TO ORDER

President Lecakes called the Convention to order in the name of the Father and of the (+) Son and of the Holy Spirit at 2:03 PM.

III. OPENING DIRECTIONS AND REMARKS

The Bishop began with a blessing to all delegates and provided a brief primer on District Conventions from the Convention Workbook. He also reminded delegates the purpose of conventions from the Synod Handbook.

He stated the following:

"The purpose of District Conventions

2016 LCMS Handbook - Bylaw4.2.1 Conventions of the districts shall afford opportunities for worship, nurture, inspiration, fellowship, and the communication of vital information. They are the principal legislative assemblies, which amend the district's Articles of Incorporation and Bylaws, consider and take action on reports and overtures, and handle appropriate appeals."

President Lecakes reminded delegates that the Convention is the principal legislative assembly, and that the convention's time together is also to be a time to remember what it is that binds us together: worship, nurture, inspiration, and fellowship

President Lecakes reminded Voting Delegates where they were to be seated and that only Voting Delegates are to be seated in this section. He also announced housekeeping issues

for delegates. In addition, he advised Guests and Advisory Delegates where they were to be seated and the position and use of mics for all delegates.

Bishop Lecakes introduced the Secretary of the Atlantic District, The Rev. Dr. Robert Hartwell who is the Senior Pastor of Village Lutheran Church and The Chapel School in Bronxville.

Lecakes also introduced the 1st Vice President of the Atlantic District, The Rev. Dr. Dien Ashley Taylor, Pastor of Redeemer in the Bronx, who will play a major role in the convention. After reviewing the floor plan and amenities of the Convention Hall, Bishop Lecakes thanked Our Savior's Lutheran Church and School in Colonie for hosting.

In addition, the Bishop thanked The Rev. Adam Wiegand, Senior Pastor of St. Paul in Saratoga Springs, and The Rev. Dien Ashley Taylor for preparing the worship and devotional services for the Convention.

Finally, the digital format of convention documents were introduced and technology announcements were made.

Bishop Lecakes welcomed special guests attending the Atlantic District Convention, including:

• The Rev. Dr. Matthew H. Harrison, the President of the Lutheran Church-Missouri Synod and

- The Rev. Christopher Esget 5th Vice President, Representing the East-Southeast Region, of the Lutheran Church—Missouri Synod and finally
- The Rev. Dr. Jeffrey Hemmer Assistant to the President

President Lecakes also noted Atlantic District President Emeritus, The Rev. Dr. David H. Benke

In addition, the bishop welcomed:

- The Rev. Dr. Greg and Edith Walton, currently from Florida-Georgia District, both originally from this district and graduates of Concordia College NY.
- The former Atlantic District LWML President, Ms. Linda Guteres.
- The current Atlantic District LWML President, Deaconess Raquel Rojas, Deaconess from Redeemer in the Bronx.

IV. REGISTRATION AND CREDENTIALS REPORT

The Rev. Dr. Robert Hartwell gave the Registration and Credentials Report.

Hartwell noted that the Convention met the quorum of 34 congregations with at least one delegate present and the report was announced as follows:

- 57 Congregations represented.
- 50 Pastoral Delegates
- 48 Lay Delegates
- 15 Advisory Delegates
- 32 Guests
- 98 Total Voting Delegates

The Rev. Chair walked the Convention through the Standing Rules for the Convention, especially standing rule #8.

Bishop reviewed this rule that allows for the Chair to call for advisory delegates to inform the assembly of their view of the matter at hand through a nonbinding poll. He indicated this would normally occur just prior to a vote of the voting delegates of the Convention.

Motion #1 The adoption of the standing rules, including #8. Moved: The Rev. Dr. David Benke, St. Peters, Brooklyn Seconded: Mr. Frank Consiglio, Holy Trinity, Middle Island Adopted by unanimous acclimation.

Motion #2 The Acceptance of the Agenda. Moved: The Rev. Adam Weigand, St. Paul, Saratoga Springs Seconded: The Rev. Henry Albrechtsen, All Saints, Lagrangeville Adopted by unanimous acclimation.

Bishop Lecakes noted that two Floor Committees were established for the Atlantic District 2022 Convention. Floor Committee One deals with theological issues and the church at large. It is chaired by The Rev. Matthew Staneck of St. John, Glendale. He further stated that Floor Committee Two is for Practical Matters and the Local Church and is chaired by The Rev. David Wackenhuth. Pastor Lecakes commented that the Floor Committees' task was to take the overtures and reports and craft the resolutions we will be discussing throughout the convention.

To recognize newly rostered congregations and workers, Bishop Lecakes called forward Atlantic District Secretary Hartwell.

V. RECOGNITION OF NEWLY ROSTERED WORKERS

Pastor Hartwell invited rostered commissioned and ordained members of The Lutheran Church—Missouri Synod, who have joined the Atlantic District during this past quadrennium, to stand and the Convention honored them with a round of applause.

VI. PRESIDENTIAL NOMINATIONS REPORT

Atlantic District Secretary Hartwell continued by directing the delegates to the Convention Workbook for the listing of pastors nominated for elected Presidential positions and announced those nominated and the names of those running on Presidential ballots. He also noted biographies of nominees and the addition of a nominee for a later election, Mr. Bill Collins and his biographical information located in the <u>Convention Supplement</u>.

The Chairman of the Elections Committee, The Rev. Daniel Cohn, the Pastor of St. John, Stuyvesant, was welcomed to the podium to lead the election of the District President. He began the election with a prayer.

Chairman Cohn introduced the delegates to their voting device, which for the first time was the delegate's own smartphone, tablet, or computer. Cohn also reminded delegates that LCEF had supplied power packs, if needed, to the delegates and that they are available at the Registration Desk. He then walked delegates through voting procedures and general rules of voting for the convention which included only delegates with voting lanyards being allowed to cast a vote. In addition, Chairman Cohn instructed delegates of a summary of voting rules which included:

- Uncontested elections may proceed via a request for acclamation
- Candidates must receive at least 50% of the votes cast to win an elected position
- In the event a clear majority is not present, serial electronic run-offs will be performed

• Lowest number of votes and/or any candidate not securing at least 15% of the vote will be removed

Several tests were conducted to test the voting system and then the election was held.

Bishop Lecakes won reelection as District President/Bishop with a majority of the votes cast.

Pastor Dien Taylor led the convention in the singing of the Common Doxology.

Mrs. Amy Lecakes was recognized as the 1st lady of the Atlantic District and flowers were presented.

VII. REPORT OF THE DISTRICT PRESIDENT

Bishop Lecakes thanked the convention for the support of his wife and family by the District. Part I of the *Report of the District President* was included in the <u>Convention</u> <u>Workbook</u>. Pastor Lecakes gave Part II of his report saying the following:

"Grace, mercy, and peace to you from God our Father and our Lord and Savior, Jesus Christ!

It truly is my honor to serve you, the members of the Atlantic District. I have never felt so humbled and in awe of the responsibility of the office you have entrusted to me. I thank you for your support, your prayers, your thoughts and more.

I must thank my wife and family for their support and sacrifice. They are a wonderful expression of living love to me, and I cherish their ongoing support.

Thank you to my staff as they continue to serve the district and carry out this event. They have assisted in overcoming so many challenges since the last convention not the least of planning a convention in a brand-new location and learning all the details with which we had grown accustomed.

Thank you to the Atlantic District Praesidium, we have experienced inordinate change over the last 4 years. Vice President Taylor has remained at my side. And Vice President Wackenhuth has moved from the 4th VP to the 2nd VP. Vice President Staneck joined the praesidium and stepped up to assist. And Vice President Vic Nelson took office just a few months ago. They are blessings to me as we gather to discuss and discern the issues, the joys, the challenges and the next steps in the district.

Thank you to the Board of Directors and the Task Force chairs. We have worked through a strange 4 years having to pivot to online meetings and the challenges of zoom, but always with the best interests of our congregations and our workers in mind as we sought navigate all that which we encounter.

The first part of my report was printed in the workbook and continues to be available online.

Living Love is the theme of this 61st Convention. Living Love was chosen because that describes us. It describes what we have received and describes how we are to engage the world with the Gospel of Hope. That has not changed.

We encounter Living Love in the person of Jesus Christ, He is the fulness of Living Love as we watch him from the pages of scripture engage the world. We see this living love on display through the healing he does. Think of Jairus' daughter, the woman who had been bleeding for years, the man born blind, or the lame man as he is lowered through the roof. We see living love in those miracles and in other miracles, like turning water to wine at a wedding, or stilling the wind so the water is calm and the fear of the disciples taken away. We see living love in His words and teachings. The reading from Luke in our opening worship was the story of the Good Samaritan. Here Jesus teaches how we are to be living love in our lives as he grows the idea of who is my neighbor. Jesus is engaging the world by being the Living Love they encounter. And the result of this living love is the creation and growth of faith.

We are called to be living love as a result of our Baptism in Jesus. It is the waters of Baptism that God claims us by water and word. It is in our Baptism that the Holy Spirit enters in and faith is created. God continues to nurture that faith through his word and through the blessed sacrament. As that faith grows that Living love grows in me. From the Lord's table I am then sent out into this world to be living love to those I meet ...to those who are my neighbor.

Missional Theologian The Right Reverend Leslie Newbigin is quoted as saying, "The church is the hermeneutic of the Gospel. The church is to make the Gospel visit the people." I can appreciate what he is getting at here. I may rephrase. The church is the expression of the Living Love of Christ as God's word is shared through the proclamation of the Gospel, through the sacraments of Baptism and Lords Supper as we receive the forgiveness of sins and life everlasting, And through us Living Love in our daily lives.

We don't change people. Christ's Living Love does, and he uses us as vessels to share Living Love with this world.

These last four years have been a challenge. The shift in this world to a postmodern mindset has already offered many challenges to the church. The world has changed. The mindsets have changed. COVID-19 exacerbated the problem in many ways. So many things have changed, and yet the problem to what ails this world has not changed. We need - Jesus. We need that Living Love and that is what we as the church have strived to do over the last 2 years. Living Love to our neighbor because Jesus describes our neighbor as everyone, as we see in the Good Samaritan.

We live in a challenging time and a challenging place. We don't just open our doors and people walk in. Many of our congregations have faced decline. What can the district do to support congregations? One of those things is Leader development. For our laity we are increasing opportunities to pour into our leaders and assist congregations in developing additional leaders. Helping leaders understand their responsibilities as it comes to the work of the church.

The district is blessed with a number of lay deacons. We are currently reviewing the program and making it even better. We are looking at adding additional continuing education classes to further develop the gifts that God has given them that they might be Living Love through their local congregations. Opportunities for lay deacons to work with the pastor to identify needs and develop a plan to meet them. These are trained lay people seeking to Engage their communities and workplaces as the Living Love of Christ.

It's not just about our lay deacons. How can we better support the elected leaders of our congregations? We are looking at a series of listening posts and opportunities aimed at our elected leaders. These gatherings are to support the sharing of ideas and understanding how we can better help them.

This ties in directly with another of our targets being Congregational support.

This has led to partnerships like the one we are developing with Concordia Plan Services. Beyond a great health plan, it is also about parish support. Can we assist in shared accounting, facility planning, budgeting, or Human Resources? How many of you have an employee manual or make sure you have all the paperwork needed in a new hire. This partnership is seeking to provide expert assistance to the business function of the congregation, so our leaders are freed to be more a part of ministry.

The partnership with Capell Barnett Matalon & Schoenfeld LLP, our lawyers, gives us expert advice to property and legal issues. They were a great support in navigating the PPP loans. They have been supportive of parishes as they pursue possible redevelopment or needed to work through tenant issues. This fall they will be doing a zoom call to share information on developing an appropriate lease. What do you need to know to protect the church?

But Congregational support isn't just about the business side. IT is also about revitalizing congregations. In cooperation with Task Force 2 and LCEF, we are offering reimagining workshops throughout the district by region. These are a series of 4 morning sessions for congregations to work through mission, vision, and making a few simple goals for the future. This is done in person through a combination of large and small group processes so that we can learn from one another as we take a step forward to restart mission after the last 2 years. For larger churches it can be building a full mission plan as you look at the next 5 years and expanding the work you are already about.

We have talked about Lay leaders and congregational support, but we also need to continue to pour into our Church Workers. How can we assist our young in ministry pastors as they get used to serving in New York? How do we better equip them to be prepared for a mission field? We are providing opportunities for theological engagement. Lectionary study groups to assist in sermon preparation that speaks to our people. Learning from those who have gone before us that have served in this field. Interviews with seasoned pastors that share the challenges they faced and the things they wished they knew when they started. We can share challenges and joys and learn from one another.

More opportunities to learn from the wisdom around our synod. Revitalizing our Pastors conferences and additional opportunities through zoom to maintain and grow our connections.

Even as we revitalize and pour into our congregations, pastors, and lay leaders, there is also a need to start new ministries. We must take the great commission seriously to Go and make disciples of all nations, because all nations are right out our door. Look around this gathering. We are a diverse people. We are blessed to be living love together. We want to celebrate this and continue to plant new ministries in places that are underserved.

As a district we must speak clearly to our context and to our Synod. When it comes to matters of diversity, we look different than most of the rest of the synod. We must lead the way in developing a voice that speaks to the challenges of the Northeast, to the challenges of New York and challenges of the inner city. Instead of walking away from these challenges we choose to stand and be living love a voice of Hope.

We need to speak with a clear voice on matters of racism and social justice. These are the areas of life that Living Love makes a difference. We will not tolerate racism of any kind, because the Gospel is for all people everywhere. We cannot walk away from issues of race. We need to embrace them head on as we share the Gospel in this context. The church is not immune from these issues. We are uniquely situated at this crossroads of the world to speak with a clear voice as these issues affect us. We cannot walk away from the downtrodden, because Jesus reaches out with arms of love. Living Love in the Gospel causes us to speak to these issues we face. God uses us, his baptized believers, to share living love to the hopeless. This is true in Racism, true in Social Justice, true for the NONEs, and true for all people everywhere. God's love is for all people, and He has given us that love.

We are the SYNOD in this place. We sit at this crossroads of the pluralism of this world. And we have an opportunity to speak and be heard, because we face these challenges each and every day. Paul writes:

23 For as I passed along and observed the objects of your worship, I found also an altar with this inscription: 'To the unknown god.' What therefore you worship as unknown, this I proclaim to you.

We proclaim the Living Love of Jesus in this world. We need to speak this truth and reality, clearly and loudly so that all voices are heard. Living Love is embracing all of our sisters and brothers, listening to their concerns and walking together to see what solution might present itself. It is going above and beyond.

We continue to seek partnerships, continue to seek guidance, because we are not perfect. We need to communicate better, hear each other and work together to see what the future holds.

Paul writes about Love. Love is patient and kind. He talks about what Love is not. It does not rejoice at wrong doing, it is not irritable or resentful. Love bears all things, believes all things, hopes all things, endures all things. – That is the Living Love that we are

talking about. That is the Living Love we are to be to each other and to the world around us, our neighbor.

These last 2 years have given us the greatest challenge I have ever faced. It has been exhausting and even a bit overwhelming. But we are still here. The message is still the same. The Living Love of Jesus hasn't changed. The Living Love of Jesus remains the message this world needs to hear. So let's take this next step together. I pledge to continue to hold you in my prayers. I pledge to seek the Lord's guidance as we seek to serve this world. I pledge to work with you in determine what the next steps for our district and your congregation are."

President Lecakes ended his remarks by making the pledge to walk with the District congregations, ministries, laypersons and workers as we together "receive the Living Love of Jesus and Engage the world around us with the Gospel of HOPE."

VIII. PRESIDENTIAL ELECTIONS

Pastor Daniel Cohn led the election of First Vice President (non-geographic) of the Atlantic District.

The Rev. Dr. Dien A. Taylor was elected 1st Vice President (non-geographic) with a majority of votes cast.

IX. TASK FORCE I REPORT

Mission Executive and the Chair of Task Force I (Missions), The Rev. Dr. Johnson Rethinasamy, Pastor of Immanuel, Whitestone shared his report along with video of ministry activities around the district.

X. TASK FORCE II REPORT

The Chair of Task Force II (Congregational Revitalization and Leadership Development), The Rev. Dr. Vic Nelson, Pastor of Lutheran Church of the Resurrection, Cairo shared his report.

Bishop Lecakes summarized that several Task Forces of the District are functioning at some level but are not able to give a report.

XI. TASK FORCE VII REPORT

Mrs. Amy Lecakes, Co-Chair of Task Force VII (Health and Human Care), gave the report of the Task Force. Lecakes is a commissioned minister of the Lutheran Church—Missouri Synod and a School Counselor at Martin Luther High School in Queens. Ms. Lecakes serves along with co-chair, Mrs. Kate Gonzalez.

XII. TASK FORCE VIII REPORT

The Chairs of Task Force VIII (Disaster Response) was given by The Rev. Tom Cusanelli, the Associate Pastor of St Luke, Dix Hills. Cusanelli reviewed the challenges and opportunities during the pandemic and the need to get LERT training to help in disasters. He also encouraged congregations and schools to partner in caring out disaster response.

Bishop Lecakes commented that the work of Task Force IX is often duplicated by Task Force 1, therefore Task Force IX was included in Task Force I reporting.

XIII.FLOOR COMMITTEE ONE

Chairman of Floor Committee One, The Rev. Matthew Staneck, Third Vice-President of the Atlantic District in Region II, was welcomed to the podium and he began by thanking his Committee Members.

Motion #3 To Dispense with the Reading of the Whereas Clauses for the Sake of Time.

Motion: The Rev. Dr. John Hannah, Emeritus Second: Mr. Ron Sommer, St. Paul, Monroe Adopted unanimously by acclimation.

Motion #4 (Resolution 2022-01-01) To Strengthen and Expand Routes to Ministry Moved by Floor Committee One.

Resolved, that these programs leading to the development of mission leaders at all levels of service be commended and recommended to the congregations of our District for use, and be it further

Resolved, that the Atlantic District in Convention send this commendation and recommendation to the 2023 Synod in convention for adoption, and be it further

Resolved, that in particular the global impact programs—EIIT, CHS, MTC—be commended to the seminaries and to the Synod in convention for strengthening and expanding, including the SMP, in scope and potential, in preparing and certifying "General Pastors" for the LCMS, and be it finally

Resolved, that the Atlantic District in Convention in July 2022 resolve to renew its 2006 commitment by pledging to raise up and prepare 100 new home-grown mission leaders, including a significant percentage of ordained pastors, in the next six years.

Discussion Occurred. Adopted by a majority vote (98Y/8N/2A).

Motion #5 (Resolution 2022-01-02) To Recognize and Give Thanks for Work at Concordia College New York

Moved by Floor Committee One.

Resolved, That we, the Atlantic District in Convention recognize, remember, and give thanks to God for the good and godly work of the many alumni, faculty, and staff

throughout the history of Concordia in the training and instruction of God's Word and Christian life; and be it further

Resolved, That we recognize, remember, and give thanks to God for the good and godly work of the many friends of Concordia which they have done and will continue to do in our congregations and communities; and be it further

Resolved, That we recognize, remember, and give thanks to God for the Care and Comfort Committee that raised dollars to support the faculty and staff members of Concordia College who were losing jobs due to the closure of the school; and be it further **Resolved,** That we give voice to our thanks and praise to God for working through Concordia College, and pray His continued guidance, as we rise and sing the Common Doxology; and be it finally

Resolved, That we memorialize the 2023 Synod in convention to adopt the above resolution.

Discussion was held.

Adopted by acclimation.

Convention rose to sing the "Common Doxology" as approved.

Motion #6 (Resolution 2022-01-03) To Explore Future Lutheran Higher Education Opportunities in the East Coast Region

Moved by Floor Committee One.

Resolved, That the Atlantic District in Convention encourages the District President to work with other District Presidents in the East Coast Region and the Lutheran Church—Missouri Synod, in identifying opportunities for the establishment of a new center for higher and professional education, either physically or virtually, based in the East Coast Region.

Discussion was held. Adopted by majority vote (91Y/2N/1A).

A friendly amendment was received by The Rev. Dr. George Kirkup

Motion #7 (Resolution 2022-01-04) Supporting Colleges and Universities of the Concordia University System (CUS)

Moved by Floor Committee One.

Resolved, that Lutherans in their congregations promote the colleges and universities of the CUS and their programs and offerings, especially programs that train workers for the Church; and be it further

Resolved, that Lutherans throughout The Lutheran Church—Missouri Synod be encouraged to support the colleges and universities of CUS with their regular prayers, precious time, diverse talents, and generous financial resources; and be it further **Resolved,** that all who have benefitted in any way through the years from the colleges and universities of the CUS support them in any way possible; and be it finally **Resolved,** that both the LCMS Atlantic District and the entire LCMS take every available step and use every gift given to them by God to ensure that the colleges and universities of CUS continue to operate with their inspiring mission for generations to come to the glory and praise of Almighty God—Father, Son, and Holy Spirit.2022 01-04 Support the CUS System. Discussion was held. Adopted by majority vote (87Y/2N/4A).

Motion #8 (Resolution 2022-01-05) Producing Religious Education Materials Moved by Floor Committee One.

Resolved, that images from Bible stories, liturgical art, and images of our Lord Jesus Christ do not only include images of people of European descent, but better reflect global artistic traditions; and be it further

Resolved, that the publication arms of the LCMS consult directly with people from diverse cultures, sociological backgrounds, and ministry experiences in the LCMS to ensure the resources are appropriate; and be it finally

Resolved, that progress on this front be reported to the Synod for the 2026 Regular Convention.

No Discussion was held.

Adopted by majority vote (81Y/8N/3A).

Floor Committee action was further explained by the Rev. Chair.

Motion #9 (Resolution 2022-01-06) To Provide Christian Resources in Addressing Racism

Moved by Floor Committee One.

Resolved, that we give thanks for the work that the LCMS has done addressing racism; and be it further

Resolved, that we, the Atlantic District in convention, likewise acknowledge our failures for not seeing racism and addressing it for what racism is in our church body and beyond, and repent of those failures; and be it further

Resolved, that we memorialize the LCMS in convention our repentance and acknowledgment of our silence to racism that have hurt God's children; and be it further **Resolved,** that curricula be developed by Concordia Publishing House to teach people about the ills of racism and how we are called to combat it; and be it further

Resolved, that these curricula developed are designed so that people of all ages and in all educational settings (homeschool, preschool, elementary school, middle school, high school, college, graduate school, seminary, Sunday School, Vacation Bible School, parish educational programs, etc.) will benefit directly and intentionally from them; and be it further

Resolved, that, in addition to the development of new curricula, educational and catechetical material dealing with the Fifth, <u>Seventh and Eighth</u> Commandments in our church body's educational resources shall address the issue of racism directly and clearly so that "racism" is not regarded simply as a side topic but as a part of the broader and necessary body of knowledge for Christians to learn; and be it further

Resolved, that sermon-writing resources be developed so that pastors will be able to identify how racism is addressed in the Holy Scriptures and be assisted in making homiletical applications for the preaching of Law and Gospel; and be it further

Resolved, that in the development of these new resources the LCMS consult directly with people from diverse cultures, sociological backgrounds, and ministry experiences in the LCMS to ensure the resources are appropriate; and be it further

Resolved, that we do everything possible so that as we in the LCMS are "making disciples for life," this church body will be known as a church body that welcomes people regardless of their ethnicity or culture in the Name of and by the grace of our Lord Jesus Christ; and be it finally

Resolved, that a copy of this resolution be forwarded to the LCMS for action at the 2023 LCMS convention.

Approved by majority vote (86Y/7N/3A).

Discussion was raised to add 8th Commandment and 7th Commandments which was received as a friendly amendment.

Motion #10 (Resolution 2022-01-07) To Address Violence Moved by Floor Committee One.

(Amended) Resolved, that first responders such as law enforcement, peace officers, mental health workers, and educators be prayerfully supported and encouraged in every appropriate way in our neighborhoods and communities; and be it further

Resolved, that the 2022 Atlantic District in convention decry gun violence and any violence that harms the lives of our neighbors as part of our proclamation of the sanctity of human life; and be it further

Resolved, that the Atlantic District in convention pray for all who have been affected by gun violence and any violence that harms the lives of our neighbors; and be it further **Resolved,** that the Atlantic District in convention strongly urge its members to steward their citizenship so that responsible action be taken that limits gun violence and any other violence in our time and in our land; and be it further

XIX. OPENING DEVOTIONS

The Session began with devotions from the Rev. Francis Rigobert.

XX. WELCOME AND CALL TO ORDER

Bishop Lecakes welcomed the Rev. Dr. Matthew H. Harrison, the Synodical President of The Lutheran Church—Missouri Synod. He noted that Pastor Harrison served as the preacher for our opening Eucharist and now addresses the Atlantic District Convention and shares the work of our Synod.

President Harrison commented on the challenges of leading the Synod through Covid-19. He also commented on the blessings of financial giving during the Pandemic. Pastor Harrison shared with the Convention his thankfulness on the ability of the Synod to help people during pandemic and provide resources.

He also addressed what he felt was an upcoming issue of the Synod in Convention in 2023. He believes that 7-03 Task Force of Concordia University System will be the issue. The main recommendation is that Regents would have the power to work independently yet that the Universities would have to be accredited in what Harrison called "Lutheran identity."

President Harrison spoke regarding the closing of Concordia University - Portland. He also commented on the closing of Concordia College – Steward and on the recent closure of Concordia College – New York.

The challenges of the Concordia University System are cost related and there are leadership opportunities and theological opportunities that are exciting, according to Harrison.

President Harrison commented on the Madagascar Lutheran Church and other exciting activities with Church Relations including work in South Korea and South Sudan.

Pastor Harrison spoke to the delegated about religious freedom issues in the Church of Finland.

He also commented on the trouble in Ukraine and fundraising to help Lutherans in Eastern Europe.

President Harrison praised the LWML which continues to support the synod in mission grants and helping women to get involved in the study of scripture.

President Harrison talked about issues of sexuality and race and stated his belief that the LCMS has the strongest teaching in these areas and that we have the ability to speak to our culture.

An update on the Office of International Mission was shared with the issues that we deal with during pandemic and the proper funding for supporting our missionaries, especially as they go back into the field following the pandemic.

Reports from Bishop Harrison included Livonian Lutheran Project and mission training in Europe as well as outreach in the Middle East and especially exciting work of our German partner church, SELK, and her mission outreach to Muslims.

The Dominican Seminary has over 30 students and are beginning to ordain pastors. According to President Harrison, they have ordained over 200 pastors.

President Harrison announced that the Spanish Lutheran Hymnal has been published by CPH and will be in an app format in about a year.

The Taiwan Seminary was discussed as well as issues related to pulling out of this joint work.

President Harrison updated the convention on Africa Seminaries and a fully rebuilt seminary in India.

In addition, the Synod Program "Making Disciples for Life" and the "Life Network", a Life advocacy of the Lutheran Church -- Missouri Synod were reviewed.

Speaking to the strength of Human Care, after the earthquake in Hatti, the LCMS church partnership in South Hatti distributed almost 400,000 meals in the disaster zone in addition to many other relief efforts of Synod.

President Harrison shared a \$3 million "Life Match" that was being offered to assist congregations with pro-life missional opportunities.

Harrison touted that over 19,000 "Everyone His Witness" workbooks have been sold, increasing Evangelism opportunities in congregations.

He also lifted up Rural and Small-Town Ministry and the upcoming "Child Protection Program" in relation to preventing sexual abuse cases

President Harrison commented again that the Synod is in "best financial shape" ever. He related this to giving and good fiscal stewardship.

He added that he hopes to share the Gospel and to help the synod stay in the business.

President Harrison commented on the financial support of seminaries and "Set Apart to Serve" church recruitment and his desire to have all of us recruit pastors for church work.

Finally, he shared a 2017 LCMS Youth Ministry Study and talked about a \$2 Million Church Planting Grant opportunity.

Time was allotted for discussion and question and answer with President Harrison.

A question was raised about student debt and work that the seminaries are doing to help church workers.

A question was raised about Harrison's comments regarding seminary education and alternate routes.

President Harrison talked about the serious issue of student debt.

The Q and A was extended to allow more with the Synod President.

The issue of racism and how to respond to conflicted issues was addressed.

The issue of Concordia College – New York closing was raised.

XXI. SERVANT OF CHRIST AWARD

The Rev Hartwell introduced the first Servant of Christ Award which was awarded posthumously to Mr. James Darden.

The Rev. David Haberer, Mr. Darden's pastor shared a little about Mr. James Darden and his servant heart and faith.

The Rev. Secretary Hartwell announced the current registrations as of 9:30 AM.
